CLC FIGHTS TO PROTECT THE 1ST AMENDMENT

RIGHTS OF CITIZENS, BECAUSE ALL AMERICANS DESERVE TO HAVE A VOICE IN THE POLITICAL PROCESS, NOT JUST THE WEALTHY FEW.

CAMPAIGN FINANCE

We fight so that everyone knows who funds our elections and how the money is spent.

We currently have **8 cases** in federal court defending transparency in elections.

We fight so that everyone can participate meaningfully in political campaigns.

In the past year, we advised advocates from **26 states**, cities and towns who wanted to pass pro-democracy reform measures.

We fight for everyone to be held accountable for breaking the rules protecting our democracy.

In the past year, we raised awareness of campaign finance abuses, filing 22 complaints with the Federal Election Commission against both Republican and Democratic candidates, super PACs and dark money groups for violating campaign finance laws.

REDISTRICTING

We advocate for solutions that will ensure a fair process for drawing maps.

In the past year, we advised advocates from 11 states on how best to design independent redistricting commissions.

We advocate for fair representation for minority voters.

In the past year, we called upon 8 local government bodies to institute processes that allow minority voters to have a choice in who represents them.

We advocate in court for voters, not politicians, to be able to choose their representatives.

We represent **40 voters** from 34 Wisconsin legislative districts whose voices have been silenced because of extremely gerrymandered voting maps. (*Gill v. Whitford*)

We represent the League of Women Voters of North Carolina and 12 individual voters in a case challenging North Carolina's congressional voting map as an extreme partisan gerrymander. (League of Women Voters v. Rucho)

VOTING RIGHTS



We fight for those who have re-entered society after prison to have access to the ballot.

CLC represents Alabama voters and Greater Birmingham Ministries in a legal challenge to the state's felony disenfranchisement system. (Thompson v. Merrill)

CLC leads a grassroots campaign, Restore Your Vote, to help up to 17 million people with past felony convictions understand their right to vote.

We fight to make it easier for Americans to vote.

As many as 600,000 Texas voters were able to vote in the 2016 election because of CLC's lawsuit challenging Texas' strict voter ID law. Our lawsuit forced the Texas legislature to rewrite the law, reducing its harmful impact on people of color, students and elderly voters.

CLC's lawsuit challenging Arizona's complicated voter registration system resulted in a settlement allowing tens of thousands of voters to register to vote in federal elections in Arizona.





We advocate for public servants to make decisions based on the public's best interest, not their own.

CLC regularly files complaints with the **U.S. Inspector General** regarding conflicts of interest and abuse of power, shaping public opinion and putting public pressure on these violators.

We advocate for the fair enforcement of ethics rules.

CLC's **complaints** with the Office of Special Counsel alleging Hatch Act violations resulted in a finding of misconduct and a referral to the White House for disciplinary action.



We advocate for a transparent decision-making process, and one in which the public has a voice.

CLC developed 13 proposals to strengthen executive branch ethics and filed over 20 ethics-related Freedom of Information Act requests seeking transparency in government.

CLC helps Alabamian Willie Mack cast a ballot.



Alabama citizen
Willie Mack thought
he couldn't vote
because of a past

felony conviction. After working with Campaign Legal Center attorneys and organizers, he was happy to learn he was wrong. We are helping individuals like Willie Mack through our organizing and training campaign, Restore Your Vote. Up to 17 million people with past felony convictions can vote right now but don't realize it. CLC developed a website, **RestoreYourVote.org**, to help educate returning citizens — in all 50 states — about their right to vote.

CLC represents 40 voters fighting for fair maps in Wisconsin.

Our plaintiffs (six pictured here outside the U.S. Supreme Court) in the landmark partisan gerrymandering case, *Gill v. Whitford*, are continuing their fight for fair maps in the courts. These voters have always engaged in politics, but since the state legislature redrew the Assembly map in secret in 2011, their voices have been silenced.

Roger Witten


