Dear Governor DeWine and Secretary LaRose:

As Governor and Secretary of State, we know you have the power to address the challenges posed by COVID-19. We appreciate your leadership on this matter and we want to ensure that the primary election is as successful as possible. We suggest the following immediate changes to ensure that Ohioans are able to vote without risking their health or unintentionally causing harm to others:

# In-person voting

- 1. **Extend the hours for early in-person voting**, particularly on Saturday, Sunday and Monday before Election Day.
- 2. **Strongly encourage state workers** who are not at high-risk of COVID-19 to serve as poll workers, as well as eligible high school and college students.
- 3. **Provide reimbursement** for all boards of elections to purchase hand sanitizer, spray disinfectant for machines, hand wipes, and portable hand-washing stations. Sanitizing wipes should be placed next to all voting equipment and all areas should be wiped down as each voter leaves.
- 4. Require election officials to utilize line management strategies that keep voters in larger spaces that are not tightly compacted. Post signage in all polling locations asking voters to maintain appropriate distances apart from each other while waiting in line. Mark intervals on the floor with tape to help voters stand appropriate distances from one another. And ensure all voting machines or booths are positioned at least three feet from one another.

#### Vote by mail

- 1. **Extend the deadline** to accept all absentee ballots that are received at the board of elections no later than 10 days following the election regardless of the date or evidence of postmark.<sup>1</sup>
- 2. Instruct county boards of elections to accept absentee ballot applications with technical errors. As advocates push voters into vote by mail, far too many applications are rejected for minor issues.<sup>2</sup> County boards should send absentee ballots to any eligible voter who has requested a ballot.

- 3. Allow voters to return absentee ballots at polling places in their correct county on Election Day by 7:30 p.m.
- 4. **Boards of elections should call voters immediately** to fix any larger problems with an absentee ballot request.
- 5. Mail absentee ballot applications to all active voters who have not yet voted.
- 6. **Educate the public** about these voting changes by authorizing emergency funds for boards of elections to advertise on mass media and other mediums.

We stand ready to help in any way we can, particularly with public education. Our organizations participate in the non-partisan voter hotline, 866-OUR-VOTE. We would make the hotline available to answer questions about these changes and ensure that all voters have the information they need in order to be able to participate in this important election.
