Dear Ms. Lang:

This supplements our response to your Freedom of Information Act (FOIA) request dated February 1, 2018, in which you requested certain records, dating since January 20, 2017, pertaining to the inclusion of a citizenship question on the 2020 Census.

At this time, I have determined that, as a matter of discretion, additional information contained in four pages previously withheld in part pursuant to Exemption 5 of the FOIA may now be released to you. These pages are enclosed, along with three additional pages without revisions to provide context.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2018). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
