THE DEPENDENCE OF POLITICAL CANDIDATES ON WEALTHY SPECIAL INTERESTS IS A SERIOUS FLAW IN OUR POLITICAL SYSTEM AND MAKES ELECTED OFFICIALS RESPONSIVE TO THEIR LARGE DONORS RATHER THAN TO THE PUBLIC. THE TREMENDOUS POWER OF SPECIAL INTEREST MONEY IN POLITICS OFTEN DROWNS OUT THE VOICE OF EVERYDAY AMERICANS, THREATENS OUR FIRST AMENDMENT FREEDOMS, AND ERODES THE FOUNDATIONS OF OUR ENTIRE DEMOCRACY. THESE REFORM SOLUTIONS INCLUDE PLACING REASONABLE LIMITS ON FUNDING OF CAMPAIGNS, COMPLETE TRANSPARENCY OF
