COMPLAINT

- 1. Aaron Bean, who represents Florida's 4th congressional district, and Florida

 Conservative Alliance a state PAC that Bean established in 2013, chaired for nearly
 nine years, and used to raise over \$2.1 million violated federal campaign finance laws
 by directing or transferring over \$1.1 million in "soft money" to Keep Florida Red PAC,
 a federal super PAC that exclusively supported Bean's 2022 congressional campaign,
 spending over \$963,000 on independent expenditures supporting Bean in that election.

 Moreover, because Bean thereby directly or indirectly "financed" Keep Florida Red
 PAC, the super PAC also violated federal campaign finance laws by raising and spending
 "soft money" in connection with a federal election.
- 2. For over twenty years, the Federal Election Campaign Act ("FECA") has prohibited federal candidates, along with their agents and entities they establish, finance, maintain, or control, from raising and spending soft money including, *e.g.*, money raised by

nonfederal committees and organizations that are not subject to federal campaign finance laws — in connection with a federal election. The transfer of \$1,128,617.59 from a state PAC that Bean established, maintained, and controlled for almost a decade to a federal super PAC, which used the funds exclusively to support Bean's own campaign, brazenly violated federal campaign finance laws that are crucial to preventing corruption and ensuring transparency in our federal elections.

3. This complaint is filed pursuant to 52 U.S.C. § 30109(a)(1) and is based on information and belief that Bean, Florida Conservative Alliance, and Keep Florida Red PAC and Benjamin Ottenhoff in his official capacity as treasurer have violated FECA, 52 U.S.C. § 30101, et seq. If the Federal Election Commission ("FEC" or "Commission"), "upon receiving a complaint . . . has reason to believe that a person has committed, or is about to commit, a violation of [FECA] . . . [t]he Commission shall make an investigation of such alleged violation."

FACTUAL BACKGROUND

4. Aaron Bean ran for Congress in 2022 and currently represents Florida's 4th congressional district.² He is also a federal candidate seeking reelection in 2024.³ Bean first filed a statement of candidacy for the 2022 election cycle on June 2, 2022.⁴ His principal

- authorized campaign committee, Aaron Bean for Congress, filed a statement of organization with the Commission the same day.⁵
- 5. Keep Florida Red PAC ("Keep PAC") is a federal independent-expenditure only political committee ("IEOPC"), commonly referred to as a "super PAC," that registered with the Commission on April 1, 2022 *i.e.*, two months before Bean filed his statement of candidacy with the Commission. Keep PAC's treasurer is Benjamin Ottenhoff.⁶
- 6. Florida Conservative Alliance ("FCA PAC") is a state PAC that registered in Florida on August 5, 2013.⁷ On its original statement of organization, which Bean signed on the committee's behalf, FCA PAC listed Bean as its "Chairman."
- 7. On August 1, 2013, around the same time that Bean registered FCA PAC in Florida,

 Bean filed a "Statement of Solicitation" with respect to FCA PAC that provided, under

 "Relationship Between Office Holder or Candidate and Organization" —

 "Establish/Control."

Florida Conservative Alliance, Statement of Org. (Aug. 1, 2013) (attached as Ex. A). In 2011, Bean had formed a previous version of "Florida Conservative Alliance" as a "committee of continuous existence" under Florida law, which he dissolved in 2013 shortly before forming FCA PAC; Bean also served as chair of the previous "Florida Conservative Alliance" and submitted a statement of solicitation allowing it to solicit funds on his behalf, which he withdrew around the time of its dissolution. *See* "Florida Conservative Alliance," Application for Certification, Committees of Continuous Existence (Oct. 27, 2011) (attached as Ex. - 8. During Bean's nine-year tenure as its Chairman, FCA PAC received contributions totaling \$2,107,579.05. 10 Among those, FCA PAC received at least \$118,500 in contributions from federal contractors, *i.e.*, persons that were, at the time of their contributions, performing on or negotiating a contract with a federal department or agency. 11 If the recipient had been a federal committee subject to FECA's jurisdiction, rather than a state PAC generally subject to state law, these contributions would have been prohibited under FECA. 12
- 9. While Bean publicly declared his federal candidacy for the first time on June 2, 2022, his public comments prior to that declaration indicate that he was contemplating running:

 Bean told reporters on April 14, 2022, that he was "talking to friends and colleagues and doing a lot of listening," and on April 21, 2022, that he was "still exploring" a run. 13 Bean was reportedly term-limited from continuing to serve in Florida's state Senate. 14
- 10. In a letter submitted to Florida election officials on April 28, 2022 *i.e.*, after nearly nine years of serving as FCA PAC's Chairman and just five weeks before Bean filed his federal statement of candidacy with the Commission Bean resigned as FCA PAC's Chairman and withdrew his statement of solicitation authorizing FCA PAC to raise funds on his behalf.¹⁵

- 11. FCA PAC designated a new chairperson on April 29, 2022. ¹⁶ FCA PAC then disbanded or terminated one month later, on May 29, 2022. ¹⁷ In a letter acknowledging the termination, the Department of State noted that FCA PAC would have to submit a final report by June 10, 2022, ¹⁸ but no such report appears to have been submitted.
- 12. On June 7, 2022, Keep PAC received a contribution of \$1,128,617.59 from FCA PAC.¹⁹

 For the 2022 election cycle, FCA PAC's contribution was one of only four that the super PAC received, and it represented over 98% of the IEOPC's total receipts.²⁰
- 13. Keep PAC reported raising \$1,148,623.84 and spending \$1,130,851.19 in total during the 2022 election cycle, with over \$963,000 spent on independent expenditures exclusively supporting Bean's candidacy, and the remainder of its spending on operating expenditures.²¹ Keep PAC effectively ceased operations after Bean was elected to Congress in the 2022 election.²²

SUMMARY OF THE LAW

- 14. Under FECA, a "candidate" is defined as "an individual who seeks nomination for election, or election, to Federal office" and crosses the statutory threshold of receiving aggregate contributions, or making aggregate expenditures, in excess of \$5,000.²³
- 15. Federal candidates must file a written statement designating a principal campaign committee within fifteen days of becoming a candidate.²⁴
- 16. FECA requires that the funds federal candidates and officeholders raise and spend in connection with federal elections comply with federal campaign finance laws. The Bipartisan Campaign Reform Act of 2002 ("BCRA") amended FECA to prohibit federal candidates and officeholders, their agents, and any entities that they directly or indirectly establish, finance, maintain or control from raising or spending funds in connection with a federal election outside of FECA's contribution limits, source prohibitions, and reporting requirements *i.e.*, so-called "soft money."²⁵
- 17. Specifically, FECA provides, in relevant part:

A candidate, individual holding Federal office, agent of a candidate or an individual holding Federal office, or an entity directly or indirectly established, financed, maintained or controlled by or acting on behalf of 1 or more candidates or individuals holding Federal office, shall not — (A) solicit, receive, direct, transfer, or spend funds in connection with an election for Federal office, including funds for any Federal election activity, unless the funds are subject to the limitations, prohibitions, and reporting requirements of this Act.²⁶

18. As such, FECA prohibits federal candidates and officeholders, their agents, and any entities that they directly or indirectly establish, finance, maintain or control — which

- includes nonfederal committees not subject to FECA from soliciting, receiving, directing, or transferring funds in connection with a federal election that are not subject to federal campaign finance laws.
- 19. Although federal court decisions have invalidated some of FECA's source prohibitions and amount limitations, as applied to IEOPCs,²⁷ those decisions left intact BCRA's statutory amendments mandating that federal candidates and officeholders cannot "solicit, receive, direct, transfer, or spend" soft money in connection with federal elections, and those requirements thus remain in effect, as the Commission itself has clearly recognized.
- 20. In Advisory Opinion 2011-12 (Majority PAC), the Commission explicitly reaffirmed that BCRA, codified at 52 U.S.C. § 30125 *et seq.*, "remains valid" after *Citizens United* and *SpeechNow*: "[BCRA] was enacted by Congress long after [FECA's] contribution limits and source prohibitions. It was upheld by the Supreme Court in *McConnell v. FEC*, 540 U.S. 93, 181-184 (2003), and remains valid since it was not disturbed by either *Citizens United* or *SpeechNow*."²⁸ In that advisory opinion, the Commission stated that federal candidates cannot lawfully solicit funds on an IEOPC's behalf that are beyond FECA's contribution limits, source prohibitions, and reporting requirements.²⁹
- 21. In MUR 7853, the Commission applied FECA's soft money prohibitions in the context of soft money transfers to an IEOPC, which spent those funds in connection with a federal election: the Commission found reason to believe and conciliated violations of 52 U.S.C. § 30125(e)(1)(A) arising from the transfer of \$126,500 from "Campaign to Elect Lance"

- Harris," a state campaign committee, to Stand for Truth, a federal IEOPC that made independent expenditures supporting Lance Harris's federal candidacy.³⁰
- 22. Moreover, the Commission also found reason to believe and conciliated a violation of Section 30125(e) by Stand for Truth, the IEOPC that received soft money from Harris's state campaign committee: because Stand for Truth received virtually all of its funding for the 2020 election cycle from Harris's state committee, the IEOPC was "financed" by Harris and violated the law by raising and spending soft money in support of his federal candidacy.³¹
- 23. Accordingly, even after *Citizens United* and *SpeechNow*, FECA clearly prohibits federal candidates and officeholders, their agents, and any other entities that they directly or indirectly establish, finance, maintain or control, from directing or transferring contributions raised outside FECA's contribution limits and source prohibitions, and/or aggregating more than \$5,000 per year, to an IEOPC.³²

CAUSE OF ACTION

COUNT I:

BEAN AND FCA PAC VIOLATED 52 U.S.C. § 30125(E)(1)(A) BY DIRECTING OR TRANSFERRING SOFT MONEY TO KEEP PAC IN CONNECTION WITH THE 2022 ELECTION

24. The available information supports finding reason to believe that Bean, a federal candidate, and FCA PAC, a nonfederal committee that Bean "directly or indirectly

- established, financed, maintained or controlled," violated FECA by directing or transferring \$1,128,617.59, either directly or through an agent, from FCA PAC to Keep PAC, a federal IEOPC, in connection with the 2022 election.
- 25. FCA PAC is a nonfederal committee, a state PAC registered in Florida, that Bean, in official statements filed with Florida authorities, acknowledged establishing, financing, maintaining, or controlling throughout virtually the entire period of FCA PAC's existence and during the nine-year period that it raised over \$2.1 million of which over \$1.1 million was then transferred to Keep PAC and used exclusively to support Bean's federal candidacy.³³
- 26. Bean formed FCA PAC and served as its Chairman from its inception in August 2013 through April 28, 2022, shortly before publicly acknowledging his federal candidacy.³⁴ Moreover, on August 1, 2013 around the time that FCA PAC registered in Florida as a state PAC Bean filed a statement of solicitation authorizing FCA PAC to raise money on his behalf.³⁵ As part of that statement, Bean acknowledged that his "relationship" to the organization was that he had "establish[ed]/control[led]" FCA PAC.³⁶
- 27. Bean remained FCA PAC's chairman, and kept the authorization to solicit funds in place, for *nearly nine years*, while using FCA PAC as a vehicle to raise over \$2.1 million during that period, including the very funds directed or transferred to Keep PAC. Only after deciding to run for Congress in 2022, and after raising all of that money, which was not subject to federal campaign finance laws, did Bean five weeks before publicly declaring his federal candidacy withdraw his solicitation statement and resign his

- position as FCA PAC's chairman. This timing strongly suggests that Bean was attempting to publicly distance himself from the state PAC shortly before the transfer of its remaining funds to a federal IEOPC.³⁷
- 28. FCA PAC was then terminated on or about May 29, 2022, approximately one month after Bean's resignation as chair, and its remaining funds appear to have been transferred to Keep PAC around the time it terminated.³⁸
- 29. On June 7, 2022, FCA PAC directed or transferred \$1,128,617.59 to Keep PAC, a federal IEOPC, which comprised over 98% of the super PAC's total receipts.³⁹ Keep PAC subsequently spent over \$963,000 exclusively supporting Bean's 2022 congressional candidacy.⁴⁰
- 30. The eleventh-hour moves to distance Bean from FCA PAC which strongly appear to be strategic actions taken in view of an imminent public filing acknowledging his federal candidacy do not alter the fact that Bean "established, financed, maintained, or controlled" the state PAC, or that the funds it raised are "soft money" that do not comport with FECA's requirements. Indeed, Bean has acknowledged that he established and controlled the state PAC during the entire nine-year period in which FCA PAC raised over \$2.1 million for him, per his signed statement of solicitation filed with Florida authorities.⁴¹
- 31. Moreover, while Bean's public comments in April 2022 indicate that he was "still exploring" whether to seek federal office, 42 his deliberate effort to distance himself from

FCA PAC just five weeks before publicly acknowledging his federal candidacy on June 2, 2022, strongly suggests that he may have deliberately delayed publicly announcing his decision to run in order to evade compliance with FECA's requirements, including its soft money prohibitions — an ineffectual attempt to avoid complying with the law, at the cost of voters' interests.

- Indeed, Keep PAC appears to have been formed for the sole purpose of unlawfully using FCA PAC's remaining \$1.1 million in soft money to support Bean's federal candidacy: the super PAC received virtually all of its funding from FCA PAC, exclusively supported Bean during the 2022 election, and ceased all activity afterward. In that regard, the fact that the IEOPC was organized on April 1, 2022 weeks before Bean resigned from FCA PAC's Chairman and two months before Bean filed his statement of candidacy with the Commission on June 2, 2022 suggests that Keep PAC's organizers knew that Bean was planning to run for Congress as early as April 2022.
- 33. Accordingly, there is ample information to establish that throughout the period that FCA PAC raised \$2.1 million for Bean, of which over \$1.1 million was transferred to a federal super PAC, Bean had established, financed, maintained, or controlled FCA PAC.⁴⁴
- 34. As a state PAC registered in Florida, raising funds subject only to Florida law, none of the money that FCA PAC raised was subject to FECA's contribution limits, source prohibitions, and reporting requirements. Indeed, at least \$118,500 raised by FCA PAC appears to have come from federal contractors, such that those contributions would have been prohibited under FECA if they had been made to federal committees.⁴⁵

Based on the foregoing, there is reason to believe that Bean and FCA PAC, an entity that Bean directly or indirectly established, financed, maintained, or controlled, violated 52 U.S.C. § 30125(e)(1)(A) by directing or transferring — either directly or through an agent — over \$1.1 million that did not comply with FECA's contribution limits, source prohibitions, and reporting requirements, to Keep PAC in connection with a federal election.

COUNT II:

KEEP PAC VIOLATED 52 U.S.C. § 30125(E)(1)(A) BY RAISING AND SPENDING SOFT MONEY IN CONNECTION WITH THE 2022 ELECTION

- 36. The available information supports finding reason to believe that Keep PAC was directly or indirectly "financed" by Bean under FECA, such that Keep PAC also violated the law by raising and spending soft money in connection with the 2022 election, *i.e.*, to make over \$963,000 in independent expenditures supporting Bean's 2022 federal candidacy.
- 37. As noted above, Keep PAC received \$1,128,617.59 from FCA PAC, which was directly or indirectly established, maintained, and controlled by Bean. ⁴⁶ Keep PAC reported raising \$1,148,623.84 and spending \$1,130,851.19 in total during the 2022 election cycle, with over \$963,000 spent on independent expenditures exclusively supporting Bean's candidacy, and the remainder of its spending on operating expenditures. ⁴⁷

- 38. Accordingly, for the 2022 election cycle, FCA PAC's contribution constituted over 98% of Keep PAC's total receipts, all of which appear to have been spent on independent expenditures supporting Bean or on the super PAC's operating expenditures.⁴⁸
- 39. Under FEC regulations, the Commission determines whether a federal candidate or officeholder directly or indirectly established, financed, maintained, or controlled an entity after examining a non-exhaustive list of affiliation factors set forth at 11 C.F.R. § 300.2(c)(2), including:

Whether a sponsor, directly or through its agent, provides funds or goods in a significant amount or on an ongoing basis to the entity, such as through direct or indirect payments for administrative, fundraising, or other costs[; or] Whether a sponsor, directly or through its agent, causes or arranges for funds in a significant amount or on an ongoing basis to be provided to the entity[.]⁴⁹

- 40. As the previous section explains, there is reason to believe Bean directly or indirectly established, financed, maintained, or controlled FCA PAC, and, as such, if FCA PAC "provid[ed] funds . . . in a significant amount" to another entity, that entity here, Keep PAC would in turn be directly or indirectly established, financed, maintained, or controlled by Bean as well.
- 41. FCA PAC's \$1.1 million contribution to Keep PAC on June 2, 2022, was the first and by far largest contribution that the super PAC received, comprising virtually all (over 98%) of its funding: Keep PAC subsequently reported receiving only three other contributions

- totaling just \$20,000. As such, FCA PAC's \$1.1 million contribution was unequivocally "a significant amount" of Keep PAC's funding.⁵⁰
- 42. Accordingly, there is reason to believe Bean, a federal candidate, directly or indirectly "financed" Keep PAC through FCA PAC.⁵¹
- 43. In turn, there is reason to believe that when Keep PAC spent FCA PAC's money all of it nonfederal funds that did not comport with FECA's requirements to pay either its operating costs or to make independent expenditures supporting Bean's 2022 candidacy for federal office, Keep PAC raised and spent "soft money" in connection with a federal election, in violation of 52 U.S.C. § 30125(e)(1)(A).⁵²

PRAYER FOR RELIEF

- Wherefore, the Commission should find reason to believe that Bean, FCA PAC, and Keep PAC violated 52 U.S.C. § 30101 *et seq.*, and conduct an immediate investigation under 52 U.S.C. § 30109(a)(2).
- 45. Further, the Commission should seek appropriate sanctions for any and all violations, including civil penalties sufficient to deter future violations, injunctive relief to remedy these violations and prohibit any and all future violations, and such additional remedies as are necessary and appropriate to ensure compliance with FECA.


