PETITIONER’S NOTICE OF VOLUNTARY DISMISSAL WITHOUT PREJUDICE

Petitioner Ernest Falls voluntarily dismisses his claims against Respondent Goins without prejudice pursuant to Tennessee Rule of Civil Procedure 40.01(1). On June 30, 2025, Respondent Goins informed the Grainger County Administrator of Elections (“AOE”) that Petitioner Falls is no longer disqualified from voting in Tennessee, as mandated by Tennessee law. *See* 2025 Tenn. Pub. Acts, ch. 298, <https://publications.tnsosfiles.com/acts/114/pub/pc0298.pdf>. The Grainger County AOE accepted Respondent’s notice and approved Petitioner’s voter registration application. Petitioner Falls is now registered to vote in Tennessee. Because this action can no longer provide Petitioner with meaningful relief, he voluntarily dismisses his claims against Respondent Goins without prejudice.
