

CONGRESSIONAL STOCK TRADING BY THE NUMBERS

SUMMARY

This fact sheet illustrates the landscape of stock ownership in the current 119th Congress. Polling shows that the public overwhelmingly supports banning members from trading individual stocks, and this overview provides transparency of the lawmakers who own individual stocks.

While the STOCK Act provides for disclosure of stock transactions and prohibits insider trading, the law does not otherwise restrict the ownership and trading of stock by lawmakers. This means that members of Congress can own, buy, and sell individual stock even where that stock will conflict with their official duties. The proposed Restore Trust in Congress Act is a bi-partisan bill that addresses the vast array of conflicts of interest caused by congressional stock trading.

As demonstrated below, some members own stock through a qualified blind trust ("QBT"), invest only in widely held investment funds, or do not invest in the stock market at all to reduce the possibility of conflicts of interest. Many members, however, do own individual stock, which continues to pose risks of actual and perceived conflicts of interest.

STOCK AND THE 119TH CONGRESS

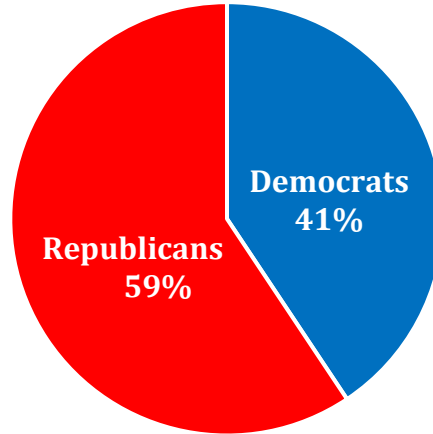
Based on annual financial disclosures and blind trust reports filed in 2025, out of 533 total members of Congress with publicly available filings,

- **48% own stock** (202 Representatives, 56 Senators). Of those, 249 own both stocks and widely held investment funds.
- **46% own only widely held investment funds** (mutual funds, ETFs, pensions) (201 Representatives, 42 Senators).
- **6% do not own stock or widely held investment funds** (30 Representatives, 2 Senators).
- **2% have a QBT** (2 Representatives, 6 Senators).

¹ These charts include assets held by spouses and dependent children. "Widely Held Investment Funds" include mutual funds, exchange-traded funds, and pensions. Stocks include public and non-public stock that are valued above \$1,000. These counts are based on the annual personal financial disclosures, new filer reports, and termination reports filed with the Clerk of the House of Representatives and the Secretary of the Senate as of November 12, 2025 and therefore are reflective of the accuracy and clarity of those records. Candidate financial disclosure reports were used for members that were sworn into Congress after the new member period (ending April 15, 2025). Members that have not filed an FD are not included in percentage calculations.
