ORDER
(September 5, 2002)

Presently before the Court are the following: 1) the Adams Plaintiffs' Motion to Compel Response to Subpoena *Duces Tecum* and *Ad Testificatum* by Non-Parties Edison Electric Institute and Thomas Kuhn [#31]; 2) Defendant FEC's Motion for a Stay of the Rule 30(b)(6) Deposition [#135], Defendant FEC's Motion for Protective Order [#134], and the RNC Plaintiffs' Opposition to Defendant FEC's motions and its own Conditional Cross-Motion for

Protective Order [#37]; and 3) a Motion to Expedite [#137] filed by all Defendants' in the eleven consolidated actions which seeks to accelerate the briefing of their Motion to Compel the National Republican Senatorial Committee's and the National Republican Congressional Committee's Responses to Document Requests [#136]. Given the expedited nature of these proceedings, it is this 5 day of September, 2002, hereby

ORDERED that non-parties Edison Electric Institute's and Thomas Kuhn's opposition to the Adams Plaintiffs' Motion to Compel Response to Subpoena *Duces Tecum* and *Ad Testificatum* by Non-Parties Edison Electric Institute and Thomas Kuhn [#31] shall be filed no later than **4 p.m. on Monday, September 9, 2002**. The opposition and three judge's copies shall be filed personally in the Clerk's Office by handing the filing to the intake representative and mentioning that the filing is part of the *McConnell* action. No extensions of this schedule will be permitted; it is further

ORDERED that the Adams Plaintiffs' reply to non-parties Edison Electric Institute's and Thomas Kuhn's opposition to the Adams Plaintiffs' Motion to Compel Response to Subpoena *Duces Tecum* and *Ad Testificatum* by Non-Parties Edison Electric Institute and Thomas Kuhn [#31] shall be filed no later than **4 p.m. on Tuesday, September 10, 2002**. The reply and three judge's copies shall be filed personally in the Clerk's Office by handing the filing to the intake representative and mentioning that the filing is part of the *McConnell* action. No extensions of this schedule will be permitted; it is further

ORDERED that before non-parties Edison Electric Institute and Thomas Kuhn file their opposition to the Adams Plaintiffs' Motion to Compel Response to Subpoena *Duces Tecum* and *Ad Testificatum* by Non-Parties Edison Electric Institute and Thomas Kuhn [#31], their counsel

shall *meet* and *confer* with Plaintiffs' counsel in an attempt to narrow or resolve their differences since it is unclear that this has been done; it is further

ORDERED that 1) Defendant FEC's reply to the RNC's opposition to Defendant FEC's Motion for a Stay of the Rule 30(b)(6) Deposition, [#135] and Motion for Protective Order [#134]; and 2) Defendant FEC's opposition to the RNC Plaintiffs' Conditional Cross-Motion for Protective Order [#37] shall be filed no later than **4 p.m. on Monday, September 10, 2002**. The reply/opposition and three judge's copies shall be filed personally in the Clerk's Office by handing the filing to the intake representative and mentioning that the filing is part of the *McConnell* action. No extensions of this schedule will be permitted; it is further


ORDERED that the RNC Plaintiffs' reply to Defendant FEC's opposition to the RNC Plaintiffs' Conditional Cross-Motion for Protective Order [#37] shall be filed no later than **4 p.m. on Tuesday, September 10, 2002**. The reply and three judge's copies shall be filed personally in the Clerk's Office by handing the filing to the intake representative and mentioning that the filing is part of the *McConnell* action. No extensions of this schedule will be permitted; it is further

ORDERED that Defendants' Motion to Expedite the briefing schedule of a motion filed by Defendants' to compel the National Republican Senatorial Committee and the National Republican Congressional Committee to respond to document requests [#137] is **GRANTED IN PART**. Non-parties the National Republican Senatorial Committee's and the National Republican Congressional Committee's opposition to Defendants' Motion to Compel the National Republican Senatorial Committee's and the National Republican Congressional Committee's Responses to Document Requests [#136] shall be filed no later than **4 p.m. on**

Monday, September 9, 2002. The opposition and three judge's copies shall be filed personally in the Clerk's Office by handing the filing to the intake representative and mentioning that the filing is part of the *McConnell* action. No extensions of this schedule will be permitted; and it is further

ORDERED that Defendants' reply to the National Republican Senatorial Committee's and the National Republican Congressional Committee's opposition to Defendant's Motion to Compel the National Republican Senatorial Committee's and the National Republican Congressional Committee's Responses to Document Requests [#136] shall be filed no later than **4 p.m. on Tuesday, September 9, 2002.** The reply and three judge's copies shall be filed personally in the Clerk's Office by handing the filing to the intake representative and mentioning that the filing is part of the *McConnell* action. No extensions of this schedule will be permitted.
